CITY OF HEALDSBURG MAYOR'S UPDATE

August 8, 2024



Recycled Water Pipeline Project: The City of Healdsburg received a \$7.1 million dollar grant from the State of California to construct the Municipal Recycled Water Pipeline Project. This project is currently under construction and is anticipated to offset approximately 25 million gallons of potable water and will help the City avoid using drinking water to irrigate large areas of turf. This allows more water to remain available for domestic purposes reducing the impacts of future droughts.

YWCA Childcare Center: Last week, the YWCA opened its first childcare center in the City of Healdsburg! The center offers year-around care, Monday through Friday. The City contributed \$600,000 to remodel two classrooms at our Community Center for the preschool to move in!

Measure O: In June, the City Council voted to place Measure O on the November 5, 2024 Election. If adopted by the voters, Measure O would allow for multifamily residential development, consistent with the General Plan, within specific areas along the Healdsburg Avenue corridor without the constraints of the GMO.

Implicit Bias Training: The first week of August, the City of Healdsburg is providing Implicit Bias training for all staff, council, commissioners, and community organizations with Dr. Bryant Marks, who is an acclaimed researcher, trainer, and educator from Morehouse College as well as the founding director of the National Training Institute on Race and Equity.

Compost Hub: In May 2024, the City of Healdsburg opened a Compost Hub in partnership with Zero Waste Sonoma. The Compost Hub is located at Badger Park and allows residents to access compost for their yard and garden year around. The compost is certified USDA organic and is produced from local facilities that process material collected from residential green carts. The compost does not contain any biosolids or manure.

Tuesdays on the Plaza: Tuesdays in the Plaza continue every Tuesday at 6:00 p.m. in the Plaza through August 27. As in the past few years, the Healdsburg Farmers' Market will also take place on Tuesdays in the Plaza and Saturdays in the West Plaza Parking Lot.

Sustaining Library Funding

Do you know how your library system is funded?

Funding for Sonoma County Library is split between property taxes (60 percent) and sales taxes (40 percent).

At the July 10, 2024 Library Commission meeting, the Commission voted to approve an ordinance and resolution placing a sales tax renewal measure on the November

5, 2024 ballot. The new measure, Measure W, would renew the 1/8 of a cent sales tax (known as Measure Y) that expires on March 31, 2027.

Sales tax funding has been crucial to the library's growth and success by allowing us to expand programs and services to all areas of the county.

We expanded our hours in November 2022 to seven days a week, and patron visits have increased 13 percent over last year. Our circulation

has grown exponentially - last year we had 4.4 million checkouts, which is 8 percent above the prior year, and higher than any other year in Sonoma County Library's history.

Adding new books and digital content to our collections is an important way we invest our tax revenue. Sonoma County Library is #5 in the state for Libby usage, and we have also expanded access by increasing outreach with our BiblioBus service.

None of this would be possible without our dedicated and friendly staff, who welcome you in to our branches every day.

This year, we are planning to purchase a second mobile library vehicle to meet the needs of all of our communities, but especially the more remote areas of the county. In our outreach efforts, we heard you loud and clear – people would like to pick up holds when they visit the BiblioBus, and we hope to provide this service with our new outreach van. Stay tuned for more information!

Economic Impact Study Details Huge Return-On-Investment

For every dollar the Sonoma County Library spends on library services, Sonoma County residents receive \$3.82 in benefits, according to an economic impact study released recently.

The report was created by Economic Forensics and Analytics (EFA), a Sonoma County-based independent research and consulting firm led by Dr. Robert Eyler.

The EFA study looked at three key areas of impact: the library's annual operating budget, its annual capital spending, and the annual household savings cardmembers receive from free library services.

Sonoma County Library Director Erika Thibault said the significant return-on-investment validates the library's role in Sonoma County as both a source of education, information, and entertainment and its substantial positive financial impact to the community.

"This report confirms that the library provides amazing resources and a huge economic boost to our Sonoma County residents," Thibault said.

The report is posted on the library website in both Spanish and English, and print copies are available at all library branches.
