Strategic Collaboration: Aligning Priorities for Unified Actions

Recommendation

It is recommended that each Sonoma County Mayors' and Councilmembers' Association Board Member, or their designated representative, continue the discussion of advancing regional collaboration.

Background

At the May 22, 2025, special Board of Directors meeting, members identified three key topics to guide a meaningful and inclusive dialogue with the County Board of Supervisors. This effort aims to ensure that the most pressing issues affecting our communities are effectively conveyed and thoughtfully addressed in countywide decision-making. The three identified priority topics are as follows:

- Mental Health & Homelessness Services We emphasize that these priorities should be considered as co-equals, recognizing their interconnected nature. A comprehensive approach to both issues will allow for more effective strategies in providing support, services, and solutions.
- Emergency Preparedness Ensuring readiness for natural disasters, crises, and unforeseen challenges is essential. We encourage cities to establish clear objectives for enhancing resilience, coordination, and response capabilities.
- Shared Facilities & Resources Strengthening interagency collaboration through shared resources, facilities, and services fosters efficiency and effectiveness. Identifying opportunities for cooperation will contribute to greater community impact.

The Board agreed to establish an ad hoc committee in collaboration with the County Board of Supervisors to streamline efforts and foster a unified regional strategy. As outlined in discussions, the committee will consist of the Association's chair and vice chair, along with select supervisors, to ensure effective coordination and representation.

Analysis/Discussion

A strategic, unified approach to local issues strengthens our ability to drive meaningful change and advocate for essential resources. To maintain momentum, a standing agenda item will be established for each Board meeting to review progress and refine priorities. While certain concerns may be widely shared, each jurisdiction brings unique perspectives and priorities shaped by its specific challenges and needs. Recognizing these differences is essential to



developing well-rounded strategies that serve our communities effectively. Members are encouraged to provide additional information to ensure strategies reflect the diverse needs of each jurisdiction. The Board Chair and Vice Chair will take the compiled priorities and insights from these discussions to engage directly with the Board of Supervisors, ensuring that the concerns and recommendations of our communities are clearly presented and advocated for at the County level.
